The intent of this letter is to outline and clarify, again, the pricing landscape and guidelines for GAF's Commercial Roofing products as we approach 2022.

Since our last Bulletin, there have been further shortages in feedstock supplies, plus additional and unexpected price increases for raw materials. We continue to experience what feels like a perpetual state of unknowns within the supply-chain.

The Not to Exceed Guidelines outlined for Q1 and Q2 of 2022 will be honored for all registered job quotes. Here is what we indicated in our Oct 13, 2021 letter:

The supply chain continues to be challenged by both supply concerns and corresponding cost inflation. We are continuously working with our suppliers and seeking new supply sources to ensure we have high quality supply of doors, frames, and components. Labor is a primary factor in cost escalation as well as persistent domestic and global supply challenges. These continue to affect the way products are priced and sourced.

Therma Tru has released their latest cost increase for 2022. This increase varies by product category versus the previous across-the-board increases seen in the summer of 2021. To accommodate these increases, Reeb will be changing our list pricing on Monday February 28, 2022 for all Therma Tru doors and door units and exterior wood doors and door units.

- Therma Tru Fiberglass will be increasing 16%\*
- Therma Tru Steel will be increasing 18%\*
- Therma Tru glass will be increasing 3%

\*Doors with insert glazing will have a percentage increase that will be less than the total slab increase. Flush Glazed doors and sidelites will be increasing 16%.

We will be increasing all 1-3/4" fire and commercial doors and door units on February 6, 2022.

- 90 minute steel RSP doors and door units will increase 7%
- Hollow Metal doors and door units will increase 40%

As we have previously stated, we will be changing list pricing on all interior doors and door units. We expected to do this in early 2022, but we are waiting to see the impacts and changes on costs of freight for South American goods, millwork, and flush and molded doors. When these factors become clear, we will announce the timing for interior retail price modification and price changes.

In previous communication, we were expecting increases from different vendors – notably Simpson, Woodgrain, and HBG. We know there are many questions about pricing for 2022. We are committed to giving as much advance notice as possible to our customers as we can. Supply will continue to be a great focus for Reeb, especially in light of continued vigorous demand.

Therefore, we will change pricing via list price changes (exterior doors and door units, Fypon, Schlage, and RiteScreen) and via discount changes on interior units. These changes will take place on February 28, 2022.

- Woodgrain doors, both interior and exterior, will increase 14%
- Simpson doors, both interior and exterior, will increase 10%
- Fypon products will increase 7%
- HB&G products will increase 3-25% depending on the category



For the last several years it has been our policy to increase our prices as needed on April 1<sup>st</sup> or later. Unfortunately, for 2022 we have been hit with a much earlier price increase on cement and are therefore forced to make our increases effective February 1<sup>st</sup>. In truth we will be paying more for cement January 1<sup>st</sup> but we decided to give our usual 30 days' notice to give you time to make you own price adjustments to your customers.

As you know most everything is costing more these days. Inflation is running just under 7% and like us you have probably received more price increases then you care to think about. For us, pretty much everything has gone up from when we last changed our prices in April of 2021; Cement, Sand, Lime, Fuel, Freight, Labor, Chemicals and more.

As in years past the biggest driver of the individual product increases is cement. The more cement in a product the higher the increase. Not only was our cement price increased earlier than last year, it was substantially higher. You will see a bag of Deck Mud for example has a much smaller increase than a bag of pure cement.

We are always reluctant to increase prices but at times it is necessary to continue to give you the quality you have come to expect from Paragon. We hope the current high fuel prices and supply chain issues will subside in the coming year and slow down the never-ending cost increases we are all facing. We appreciate your understanding and continued purchases of our products. We do not take your business for granted and will always strive to give you the best products possible at a fair price.
